WATERWORKS RATE POLICY

On March 22, 2017, Council enacted a bylaw to fix the rates to be charged for the use and consumption of water and to fix the rates by way of rent and service charge for the use of sewer commencing April 2017.

The monthly water rate that was established on March 22, 2017 was chosen to be a rate that would be affordable for residents and businesses. The monthly water rate will generate enough waterworks revenues to cover the waterworks operating cost; but the monthly water rate does not include an infrastructure charge. Some municipalities use an infrastructure charge to collect revenue that is put into reserves so that they are able to address waterworks infrastructure problems that arise and replace aging waterworks infrastructure as required, and as such the council will be monitoring those expenses to determine if a rate increase is required.

Current Monthly Water Rates as approved by Bylaw 2017-3

- Minimum Charge - \$45.00/month (3,000 gallons)
- Over 3001 gallons - \$1.50 per 1000 gallons pro rated per usage

The objective of the waterworks rate policy is to work towards waterworks that are self-financing, where the users pay for the cost of the service. To accomplish this, waterworks rates will need to increase over time so that the revenues cover operating costs, to the extent possible. Council will review its waterworks policy to determine if revenues are covering costs. Council will consider increasing rates to build waterworks reserves in order to cover future infrastructure maintenance and replacements costs identified in the 2010 waterworks system.

This waterworks rate policy will work towards a financially independent waterworks that does not have to compete with other key municipal financial demands under the municipal general revenue fund. This will ensure our waterworks can provide safe drinking water. Also rates that cover cost will influence consumer demand and water conservation and self-financing waterworks will reduce pressures on property taxes. Reduced funding for the waterworks from the general revenue fund will be reflected in future mil rates.

WATERWORKS CAPITAL INVESTMENT STRATEGY

The objective of a waterworks capital investment strategy is to address anticipated waterworks infrastructure maintenance and replacements in a timely fashion so as to ensure the municipal waterworks provides safe drinking water to residents and businesses. The strategy uses the 2010 waterworks assessment that was required by Saskatchewan Environment for infrastructure planning. Council is currently anticipating a DUIS study and water works Phase 1 study to be provided by Associated Engineering.

To cover the costs of future waterworks infrastructure maintenance and replacements, Council will need to review a future possibility of increasing water rates to build the waterworks reserves, once the water rates cover waterworks operating costs and long term borrowing that would be associated with possible new infrastructure.

This capital investment strategy will ensure that safe drinking water can be provided to the residents and businesses in the community in the present and future.
