WATERWORKS RATE POLICY

On May 8, 2018, Council enacted a bylaw to fix the rates to be charged for the use and consumption of water and to fix the rates by way of rent and service charge for the use of sewer commencing June 2018.

The monthly water rate that was established on March 22, 2017 was chosen to be a rate that would be affordable for residents and businesses. It is anticipated that the monthly fees that include water, sewer and a new infrastructure fee will generate enough waterworks revenues to cover the waterworks operating cost. With the addition of an infrastructure fee, that amount will be put into reserves so that they are able to address future waterworks infrastructure problems that arise and replace aging waterworks infrastructure as required. Council will be monitoring those expenses to determine if a rate increase is required in future years to ensure that this user service is self-sustaining.

Current Monthly Water Rates as approved by Bylaw 2018-06

- Minimum Charge \$20.00/month (3,000 gallons)
- Over 3001 gallons \$1.50 per 1000 gallons pro-rated per usage

Infrastructure

- Per water or sewer connection - \$25.00 regardless if water or sewer is used.

The objective of the waterworks rate policy is to work towards waterworks that are self-financing, where the users pay for the cost of the service. To accomplish this, waterworks rates will need to increase over time so that the revenues cover operating costs, to the extent possible. Council will review its waterworks policy to determine if revenues are covering costs. Council will consider increasing rates to build waterworks reserves in order to cover future infrastructure maintenance and replacements costs identified in the 2019 Conceptual Study for Water and Wastewater System Upgrades.

This waterworks rate policy will work towards a financially independent waterworks that does not have to compete with other key municipal financial demands under the municipal general revenue fund. This will ensure our waterworks can provide safe drinking water. Also rates that cover cost will influence consumer demand and water conservation and self-financing waterworks will reduce pressures on property taxes. Reduced funding for the waterworks from the general revenue fund will be reflected in future mil rates.

WATERWORKS CAPITAL INVESTMENT STRATEGY

The objective of a waterworks capital investment strategy is to address anticipated waterworks infrastructure maintenance and replacements in a timely fashion so as to ensure the municipal waterworks provides safe drinking water to residents and businesses. Council contracted Associated Engineering to complete a Downstream Use and Impact Study (DUIS) and a Conceptual Study for Water and Wastewater Treatment System Upgrades. Within the report, recommendations for upgrades to both water and wastewater/lagoon facilities are included. The Town of Lemberg was fortunate to receive funding under the New Building Canada Fund for a total lagoon upgrade of \$2,685,000. Requests for proposals for engineering services and pre-design/design are anticipated in 2019 with construction to commence in the spring of 2020. Funding sources include the Federal and Provincial governments with 2/3 of the project costs and the remaining to be funded through the Town by way of debentures.

To cover the costs of future waterworks infrastructure maintenance and replacements, Council will need to review a future possibility of increasing water rates to build the waterworks reserves, once the water rates cover waterworks operating costs and long term borrowing that would be associated with possible new infrastructure.

This capital investment strategy will ensure that safe drinking water can be provided to the residents and businesses in the community in the present and future.
