DO YOU REQUIRE A BUILDING, DEMO OR MOVE PERMIT?

Safety is our priority with respect to any new builds, additions or renovations. The Building Bylaw enacted many years ago required an approved permit for most building renovations, additions, new builds, etc. as well as the removal of any building located within the Town of Lemberg. In addition to a permit, inspections are required to ensure your project follows the National Building Code. If you have any projects that you're thinking of starting, please contact the Town Office.

Examples of projects that require building permits and inspections include, but are not limited to, most renovations and additions, decks, garages, and sheds, even if they are being moved in. A fence does not require a building permit. Permits ensure that your project will safely comply with the National Building Code. Demolitions, move-ins and removals of structures all affect the value of your assessment which affects taxation.

Stop in, phone or e-mail the Town Office and we will provide you with the necessary forms and information. You will be put in touch with our Building Official responsible for reviewing your plan to ensure your project aligns with the National Building Code.

WATER TREATMENT UPGRADE

The Town hired Beckie Hydrologist and Andrew and Sons to complete Phase I of the upgrade to our water treatment plant. During this phase, a test well was drilled and a piezometer was placed in the well to monitor the pressure of the groundwater as well as sample the water.

The next step is to receive the analysis from the water sample and determine if the 2018 conceptual study is still relevant to the needs of our Town. During this conceptual study, it was noted the Town water has high levels of ammonia, low free chlorine residual, and the presence of organic carbons. Our treatment is unable to reduce sulphate, total hardness, and total dissolved solids.

Why Reverse Osmosis (RO) water? RO removes contaminants and reduces ammonia and organic carbon levels. While RO does result in a high volume of reject water there is a way to reduce that by blending treated water with pretreated water.

Can we have a water treatment plant without RO? There was one option provided in our conceptual study which treats the water with Gas Chlorine. However, this option presents a safety risk. Furthermore, while it would solve our high ammonia levels it does not correct other provincial regulations that the Town does not meet.

What's the next step? Proceeding with a full WTP upgrade, we are hopeful government funding will become available. Another option for completing Phase II (digging of the new well), without government funding, is available and will depend on the results of our water chemistry from the sample taken.
