2023 TRAFFIC BYLAW

**A BYLAW OF THE TOWN OF LEMBERG, IN THE PROVINCE OF SASKATCHEWAN
TO ESTABLISH A TRAFFIC BYLAW.**

COUNCIL of the *Town* of **Lemberg**, in the Province of Saskatchewan, enacts as follows:

TITLE

1. This Bylaw may be referred to as “2023 Traffic Bylaw.”

INTERPRETATION

2. The authority for this Bylaw is found pursuant to *The Traffic Safety Act*, of the Province of Saskatchewan.
